

ORDINANCE 2010-04

AN ORDINANCE TO AMEND AND RE-CREATE SECTION 11.01.03 and 11.02.03 OF THE CODE OF ORDINANCES, TOWN OF LAVALLE, SAUK COUNTY, WISCONSIN.

Whereas, the Town Board previously adopted by reference former sec. 30.715, Wis. Stats., which has since been renumbered to sec. 30.07, Wis. Stats.;

Whereas, the Town Board desires to adopt by reference sec. 30.07, Wis. Stats., which pertains to the transporting of aquatic plants and animals, for the benefit of the public health, safety, and welfare, and to preserve the natural habitat in Lake Redstone and Dutch Hollow Lake.

NOW THEREFORE, the Town Board of the Town of LaValle, Sauk County, Wisconsin does ordain as follows:

Section 1. Section 11.01.03 of the Code of Ordinances, Town of LaValle, Sauk County, Wisconsin entitled "State Boating and Safety Laws Adopted" shall be amended to read as follows:

State Boating and Safety Laws Adopted

Statutory provisions found in sec. 30.07, and secs. 30.50 to 30.71 inclusive, Wis. Stats., are hereby adopted by reference as a part of this Chapter as if fully set forth herein. Any act required to be performed or prohibited by the provisions of any statute incorporated by reference herein is required or prohibited by this Chapter.


Section 2. Section 11.02.03 of the Code of Ordinances, Town of LaValle, Sauk County, Wisconsin entitled "State Boating and Safety Laws Adopted" shall be amended to read as follows:

State Boating and Safety Laws Adopted

Statutory provisions found in sec. 30.07, and secs. 30.50 to 30.71 inclusive, Wis. Stats., are hereby adopted by reference as a part of this Chapter as if fully set forth herein. Any act required to be performed or prohibited by the provisions of any statute incorporated by reference herein is required or prohibited by this Chapter.




